Bidding documents may be purchased within office hours of 30th day from first notice published day from the above office and the Procurement Unit of the Nepal Electricity Authority, Durbar Marg, Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon cash payment of a non-refundable fee of Rs amounting Rs 5000.00 or deposited in the project account No.062300000022524 at bank of Kathmandu, Naya Baneshwor, Kathmandu.
4. Sealed Bids must be submitted to the above office Kharipati, Bhaktapur **on** or before 12.00 hours **on 31st day of first bid published**. Documents received after this deadline shall not be accepted.

The Bidders who choose to submit their bid electronically through e-procurement section of NEA'S website <http://nea.org.np> may either purchase the hard copy of bidding documents or may download the necessary sections of the bidding documents and prepare and submit their electronic bids as specified in the instructions to bidders. In case the bidders choose to submit the bids electronically, the bidders shall be required to deposit the nonrefundable fee as specified above and submit a scanned electronic copy (in pdf format) of the bank deposit voucher along with the electronic bid files.

5. Bids shall be opened in the presence of Bidders' representatives who choose to attend 13.00 hours on 31st at the office of **Tanahun Hydropower Limited, Kharipati, Bhaktapur**. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amounting Rs.3,00,000.00, The Bid Security shall be **valid for minimum 30 days** beyond the bid validity period.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
