1. Tanahu Hydropower Limited (“the Employer”) is the implementing agency for the construction of 140 MW Tanahu Hydropower Project (“the Project”). Damauli Bharatpur 220 kV Transmission Line will be constructed to evacuate the power generated from the Project. Hence, the Employer intends to conduct the “**Supplementary Initial Environmental Examination of Damauli Bharatpur 220 kV Transmission line**”. This invitation for sealed quotation is made to invite applications from interested and eligible local consulting firms registered in Nepal under GoN rules and regulations and/or their joint ventures.
2. The consulting firm who has successfully completed Initial Environmental Examination /Supplementary Initial Environmental Examination of 132 kV or above 132 kV transmission line having length more than 30 km within last five years can apply either singly or in joint venture such that the total number of firms including the lead firm does not exceed a maximum of three consulting firms. However, the same firm is not allowed to enter into more than one joint venture for the same work.
3. Sealed quotations must be valid for a period of 45 days after opening of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to Rs. 25,000.00 (Twenty Five Thousand Rupees only) which shall be valid for 75 days after opening of the Sealed Quotations.
4. Sealed Quotation document along with Terms of Reference (TOR) may be purchased by eligible Consultants or their authorized person from office during office hours on all working days on the submission of a written application, up to date firm registration certificate, VAT registration certificate, Income tax clearance certificate up to Fiscal Year 2071/72, and Bank Voucher evidencing the deposit of Rs.1000.00 in Account No 062300000022524 at Bank of Kathmandu, New Baneshwor, Kathmandu and submit the receipt of the deposited amount of cash along with the application.
5. Duly completed sealed quotation documents in hard copy should be submitted to the address mentioned below clearly mentioning the name of the project in sealed envelopes.

8. The sealed quotation submitted by consultant or their joint venture received within the specified date and time will be opened in the presence of the applicant or their authorized representatives. Absence of any applicant (or their authorized representative), however, shall not obstruct or prevent the opening of the sealed quotation in any way.
9. The sealed quotation documents submitted by consultant or joint venture Firms will be evaluated on the basis of Least Cost Based Selection (LCBS) procedure.
10. The Employer reserves the right to accept or reject any or all sealed quotation proposals with or without giving any reason whatsoever.
